To overcome the challenges, we are proud to introduce you to our new Online Portal for Consignee Return Containers which enable the consignees to book and schedule their OTC container's movement to KDSLL.

Therefore, to have a seamless service, we are grateful if you kindly pass the link: https://kdsll.com/booking to your stakeholders/C&F Agents so they can book Consignee Return Containers to our Depot. This website allows you to upload Booking documents (Risk Bond, Customs Pass and MLO NOC) to our portal along with payment receipts to confirm your booking at our Trailer Parking Terminal.

With effect from 1st of October 2025, to portal will be available for OTC. Please see the Tutorial (link: https://kdsll.com/booking/guide_en.html) on the website for better understanding. To make the initiative successful, you request you to inform your stakeholders/C&F Agents, after booking in the portal for OTC container to direct the OTC vehicle to our Parking (location: https://maps.app.goo.gl/M2zMEXavvYVTG4B77), before getting call to enter the Depot premises.
